The Time & Place

The conference exhibits will be held at the Westin LAX Hotel, 5400 West Century Blvd, Los Angeles CA 90045.

Beyond conference attendees, the general public will be invited to view the exhibits without charge.

Exhibits will be open 10am-6pm on Friday, Saturday and Sunday, July 22-24. Setup will be Thursday 4pm-7pm and 9am-10am Friday. Breakdown will be after 6pm Sunday and 8-10am Monday. The hotel may discard items not removed by that time.

Each exhibit consists of a skirted 6' table (or equivalent space) and 2 chairs. Display height is limited to 7 ft for wall exhibits and 5.5 ft for all others. Location will be assigned by the Exhibit Manager with priority given to sponsors, multiple tables, and early registrants.

Exhibit materials can be shipped to the hotel to arrive no earlier than one week before the event. They should be addressed as above, marked "For Animal Rights 2011" and with the exhibitor's name and number of boxes (1 of 3, 2 of 3, 3 of 3, etc.)

The Finances & Perks

The fees are \$250 for a non-selling nonprofit, \$325 for a selling nonprofit, and \$500 for a commercial firm.

A limited number of wall spaces are available for an additional \$50. The fee for electric hookup is \$25. Phone hookup must be arranged with the hotel.

No space will be held without prepayment.

Exhibit fees are refundable less a \$50 processing charge upon written cancellation, if postmarked by June 30th. If FARM/AR2011 has to cancel the exhibits through circumstances beyond its control, its liability will be limited to full refund of exhibit fees.

Each exhibitor is entitled to two **exhibitor badges** per table, which provide admission to the exhibit hall and morning/evening plenaries. There is no admission charge to the exhibit hall for additional tabling assistants. Full registration fee for an exhibitor is \$120.

The Fine Print

None of the literature may advocate animal exploitation or attack any organization advocating animal protection or veg'ism. None of the products displayed may contain animal ingredients or be tested on animals.

No exhibit may be operated in a manner that detracts from the effective operation of other exhibits or the conference. Activity may not extend outside the assigned space. Attaching signs to walls and loud sounds are prohibited.

Each space will be pre-assigned and may not be changed or re-assigned without authorization of the Exhibits Manager. We reserve the right to make minor layout adjustments.

Selling of hot meals is prohibited, but unheated foods may be sold. All food must be 100% vegan (no animal products).

Any exhibitor violating these conditions will be offered an opportunity to make the needed correction. Problems will be adjudicated by the Exhibits Manager and the Conference Chair and may result in expulsion and forfeiture of fees.

Exhibitor agrees to hold harmless FARM, Animal Rights 2011, the Westin LAX, and their employees and agents against any property or other losses or claims arising out of their use of the exhibit premises.
