EXHIBITOR CONTRACT

Time/Place

Exhibits will be located in the Plaza Ballroom and Foyer on the Lower Level of the Hilton Mark Center Hotel located at 5000 Seminary Road, Alexandria, VA 22311; Phone 703-845-1010.

Each exhibit consists of a skirted 6' table (or equivalent space) and 2 chairs. Spaces will be assigned by the Exhibit Manager with priority given to sponsors, commercial tables, and early registrants.

Exhibit materials can be shipped to the hotel to arrive no earlier than one week before the event. They should be addressed as above, marked "For Animal Rights 2008" and with the exhibitor's name and number of boxes (1 of 3, 2 of 3, 3 of 3, etc.)

Exhibits are open to the public between 9am-6pm on Friday, Saturday and Sunday, August 15-17.

Setup times will be 4-10pm Thursday, August 14, and 8am-9am Friday, August 15. Breakdown times will be 6-10pm Sunday, August 17, and 8-10am Monday, August 18. The hotel may discard items not removed or secured after that time.

Fees

\$500 for a commercial business. \$300 for a selling nonprofit. \$200 for a non-selling nonprofit.

A limited number of tall/wall spaces are available for an additional \$50 (fee is refunded if wall space is unavailable). Other tables must be below 5.5'. Additional fees apply for electric hookup. Phone set-up is arranged directly with the hotel.

No space will be held without prepayment.

Exhibit fees are refundable less a \$50 processing charge upon written cancellation, if postmarked by July 15. If FARM/AR2008 has to cancel the exhibits through circumstances beyond its control, its liability will be limited to full refund of exhibit fees.

Each exhibitor will receive two exhibitor badges per table, which provide admission to the exhibit hall and evening plenaries. To attend the full conference, including day sessions & videos, exhibitors can purchase up to two full registrations for the discounted rate of \$120 each. **There is no charge and no limit to the number of visitors assisting with tabling.**

The Fine Print

None of the literature may advocate animal exploitation or attack any organization advocating animal protection or veg'ism. None of the products may contain animal ingredients or be tested on animals.

No exhibit may be operated in a manner that detracts from the effective operation of other exhibits or the conference. Activity may not extend outside the assigned space. Attaching signs to walls and loud sounds are prohibited.

Each space will be pre-assigned and may not be changed or re-assigned without authorization of the Exhibits Manager. We reserve the right to make minor layout adjustments.

Any exhibitor violating these conditions will be offered an opportunity to correct the violation. Failure to comply will be adjudicated by the Exhibits Manager and the Conference Chair and may result in expulsion and forfeiture of fees.

Exhibitor agrees to hold harmless FARM, Animal Rights 2008, the Hilton Mark Center Hotel, and their employees and agents against any property or other losses or claims arising out of their use of the exhibit premises.
